Includes the Monitoring Avian Productivity and Survivorship (MAPS) Program that completed its 20th year in 2008 with over 400 stations operating across North America. Over the years it has resulted in over 190 technical reports and 40 scientific papers dealing with the ecology, demography, management, and conservation of bird populations.

4b (Code:) (Expenses \$ **129,981** including grants of \$ **0**) (Revenue \$ **177,548**)
Research, inventory, monitoring, and conservation of birds in the Sierra Nevada mountains of California and elsewhere in the western United States, especially national parks. Since 1999 has resulted in 50 technical reports and 6 scientific papers dealing with the breeding ecology, fire ecology, management, and conservation of birds.

Development and operation of long-term, large-scale research and monitoring programs on wintering landbirds, including those wintering in Mexico, Central America, the Caribbean, and northern South America.
